BY SIGNING THIS FORM, I (THE PERSON(S) DESCRIBED IN G BELOW) GIVE THE FOLLOWING ACKNOWLEDGEMENTS AND CONSENTS:

A -MY ACKNOWLEDGEMENT THAT HOLDEN FINANCE MAY DISCLOSE MY PERSONAL INFORMATION TO CREDIT REPORTING AGENCIES

I understand that the Privacy Act allows Holden Finance to give a credit reporting agency certain personal information about me at any time after making my application. This information includes:

- my full name, including any known aliases, my sex and my date of birth;
- a maximum of three addresses, consisting of my current or last known address and two immediately previous addresses; the name of my current or last known employer; my driver's licence number;
- details of cheques drawn by me which have been dishonoured more than once;

and if I am applying for consumer credit or commercial credit:

- that I have applied for credit and the amount;
- that Holden Finance is a current credit provider to me;
- details of payments which are more than 60 days overdue and for which debt collection action has commenced;
- advice that payments are no longer overdue;
- that Holden Finance's loan to me has been paid or discharged; and
- that, in certain circumstances, I have committed a serious credit infringement.
